Once a contractor has been selected. It is the responsibility of the contractor to upload insurance documents into MGO Connect referencing the adjacent property owner and project number on the insurance naming NTMWD as an additional insurer and a waiver of subrogation for all insurance coverage. Providing the correct documentation is mandatory before any work can be performed on shoreline or on NTMWD property.
